SUPPLY OF THREE MAGNETIC RESONANCES FOR THE HEALTH SERVICES MANAGEMENT CENTRES OF THE HEALTH AREAS OF LANZAROTE, FUERTEVENTURA AND PALM ANNUALITY 2017.

Description of the operation:

The following is presented as good practice: the aid received in concept of acquisition of the supply, drafting of the project and execution of the works of installation of three magnetic resonances destined to the Management Centres of sanitary services of the Health Areas of the Government of the Canary Islands in Lanzarote, Fuerteventura and La Palma.

The technical conditions to be met by this equipment include the guarantee and subsequent maintenance of electromedical equipment, as well as a works project and installation (including Quench and Faraday Cage, electrical and gas installations, dismantling of old installations, installation of voice and data and air conditioning) to be installed in the assigned space, duly reviewed by the Authorized Control Body for start-up.

This investment priority is intended to help finance and achieve the objectives set out in the III Canary Islands Health Plan 2014-2017, a strategic instrument for the planning and coordination of health activities that contemplates improvements to the health system of the Autonomous Community.

-Eligible Public Expenditure: € 3,568,327 -ERDF aid: € 3,033,078

An impact of 504,079 people covered by this health service was reached.

Justification of Good Practice Criteria:

1-High level of dissemination among beneficiaries and the general public

This action was disseminated on the Canary Islands Government's website, with a generic promotional video that was broadcast in December 2017, and with other communication tools, including a poster that was placed in Health Centres, which indicated the co-financing with ERDF funds and the dissemination of the action by means of Press Releases with notable impact in the Islands' written and digital press.



El concurso, que ha sido publicado en el Boletín Oficial de Canarias (BOC) de este lunes, cuenta con un presupuesto de 3.706.000 euros, cuya inversión fue aprobada por el Consejo de Goblerno el pasado mes de marzo. El 85 por ciento de esta cantidad será financia por el Fondo Europeo de Desarrollo Regional (FEDER), dentro del Programa Operativo Canarias 2014-2020.

2.-Incorporation of innovative elements.

Resonances work throughout the configuration of the other computer systems of the hospital. With

this action, a total integration of all the participants in the diagnosis is pursued, making it possible for the results obtained through the image to be read and consulted by personnel from different medical services, even from the Primary Care Management Centres, which are the patient's first treatment and consultation centres.

3.-Adaptation of the results obtained to the established objectives.

These investments take into account that the remoteness of the archipelago leads to less use of synergies and economies of scale. For this reason, the service units on some islands are set up for a potential beneficiary population, smaller than that which would correspond in continental territories, which increases inequality in relation to the rest of the territory.

For this reason, the planned investments have a special impact on hospitals with a view to improving and incorporating the necessary infrastructures, thereby promoting, on the one hand, the use of new information and communication technologies with regard to patient care and, on the other hand, integration with other diagnostic services.

4. It contributes to the resolution of a problem or weakness detected in the field of execution.

This action has enabled the incorporation, on three islands (Lanzarote, Fuerteventura and La Palma), of equipment that was lacking, avoiding the transfer of patients to the capital islands, for the performance of any diagnostic test that requires an MRI. Therefore, not only does the technique come closer to the population of the non-capital islands but, in this way, the existing inequality between patients residing in the larger and smaller islands is eliminated.

5.- It has a high degree of coverage over the target population.

The implementation of the MRI service benefits the entire population living in Lanzarote, Fuerteventura and La Palma. These policies are directly related to the reduction of waiting lists for diagnostic tests, bringing the provision of services closer to citizens and reducing inequalities between patients living on islands other than those of their main hospital.

6.- Consideration of the horizontal criteria of equal opportunities and non-discrimination, as well as social responsibility and environmental sustainability.

When it comes to the treatment of patients, there is no discrimination on the basis of gender. Patients are treated according to the diagnosis and treatment required by the disease they suffer from, and therefore equality of opportunities is assured for all users. These actions are governed by the principle of equality, preventing any type of discrimination, including gender discrimination. With regard to the environmental impact, the installation of this equipment respects all the regulations required by the Public Administration at the time of contracting.

7.- Synergies with other policies or instruments of public intervention.

This action complements others foreseen in the III Health Plan of the Canary Islands which affects equipment and infrastructure policies, with the aim of achieving true social cohesion by facilitating the inclusion of different groups in society (including immigrants), guaranteeing all of them the provision of basic services such as health, education or social housing.

This measure is also in synergy with the Quality Plan for the National Health System of the Ministry of Health and Consumption, which foresees strategies that guarantee the maximum quality of health care for all citizens, promotes clinical excellence and, at the same time, offers useful tools to professionals and those responsible for health in the Autonomous Communities with the aim of improving quality.
